Privacy policy in accordance with Regulation (EU) 2016/679 on the protection of personal data (GDPR).

Dear user,

In order to use the services provided by In.Te.S.A. S.p.A. (hereinafter referred to as "INTESA") in its capacity as a Trust Service Provider (TSP) and, in particular, the Qualified Electronic Signature and/or Qualified Electronic Timestamping services, you will be asked to send INTESA some of your identification data. These data constitute Personal Data in accordance with the General Data Protection Regulation (Regulation (EU) no. 2016/679 - GDPR), in relation to which you are the Data Subject.

Our Privacy Policy regarding the processing of personal data by INTESA in its capacity as Data Controller is set out below.

The Personal Data obtained by INTESA is collected in accordance with Article 6.1 (b) of the GDPR and processed within the European Union, in accordance with the regulations in force.

1. Types of Personal Data processed by INTESA


1.1 INTESA collects the following types of data in order to allow you to register for the services:

1.3 Optionally, at the request of the applicant, information may be collected concerning:

- a. inclusion, if applicable, in an internationally recognised registry;
- b. powers of representation within the applicant's organisation.

2. Source of Personal Data

The Personal Data held by INTESA are collected directly from the applicant at the time of requesting the service.

Data collection is carried out when you enter your personal data in the registration form or when you use one of the other registration methods offered by INTESA and described in the Operating Manual.

3. Purposes of processing

The sole purpose of collecting personal data or processing such data is to fully comply with the obligations relating to the performance of the tasks of the Trust Service Provider, and in particular to:

- a. verify the identity documents provided for the purposes of implementing anti-counterfeiting measures;
- b. issue the electronic certificate;
- c. carry out any communication that could be useful for the purposes of correctly fulfilling the role of Trust Service Provider;
- d. manage any complaints and/or disputes;
- e. prevent/combat fraud and any other illegal activity;
- f. comply with obligations under law, regulations, or EU laws in relation to the provision of trust services.


4. Processing methods

The data are processed using manual and electronic means.
